## Hoosier Classic Select Yearling Sale

October 28 & 29, 2016 Indiana State Fairgrounds

### April 1, 2016 Entry Application due

- Application form listing each yearling applying to enter.
  - o Pedigrees will be graded for quality. First cut made. Inspection date will be set for yearlings making first cut.

### May 15, 2016 Stake Nominations/Payments due

- We recommend all yearlings be nominated to no less than 5 stakes not including Indiana sired/fair events. Serious buyers want to maximize the return on their investment.
- Stakes guides available from USTA. Payments payable to respective entities.
- All yearlings must be freeze branded and registered with the USTA.

### June 1, 2016 Entry Contracts, Entry Fees, Stakes Lists due

- Completed and signed contract for each yearling accepted.
- Send original signed USTA registration certificate with contract.
  - o Signature for each owner must be on reverse side or on Application of Transfer form. Forms available from USTA or our office.
- \$275.00 catalogue fee for each accepted yearling.
  - Only those consignors having paid catalogue fees by June 1 are eligible for the 50% sale day payment.
- List showing all stake engagements for each yearling.

### July 30,2016 Pedigree corrections due

- All corrections that need to be made on pedigree page
  - o Pedigree pages will be sent late July for proofing
  - Make sure foaling date, freeze brand number, sex, sire/dam, and stakes engagements are correct.
  - o The in-depth pedigree will be updated just prior to print

### September 2, 2016 TrackIT pedigrees on line

- Daily updated TrackIT pedigrees are available to view on www.hoosierclassicyearlingsale.com
- \* Carefully chart vaccinations, worming, and trimmings throughout the year. Vaccinations should be recorded on a veterinarian office form. Some buyers and tracks will not accept vaccination records unless they are signed by the administering veterinarian on an office document.
